THE STATE unit of the BJP is in for a major organisational restructuring by appointing office-bearers from mandal level to state-level. A meeting of the BJP parliamentary board was also held during marathon proceedings behind closed doors on Monday, party sources said.

Gujarat BJP held a high-level meeting at Shree Kamalam at Koba near Gandhinagar to discuss strengthening of the party in the state, party spokesman IK Jadeja said in a release.

The meetings were chaired by state unit president RC Faldu and attended by Chief Minister Anandiben Patel, state in-charge Dinesh Sharma, national vice-president Purushottam Rupala, city mayors, Jadeja added.

Faldu said that the party would have to pull up socks in view of election results in rural areas and increase its activeness in coming days even while the people had always reposed faith in the BJP as seen in the urban ar-

reach out to people with programmes of public welfare and propagate among them the various welfare programmes started by the state government.

He exhorted the party workers to take up the organisational restructuring work right from booth level to Pradesh level. CM Anandiben Patel while greeting elected members, told them they should not fall short of expectations of the people who voted them to power. They should prove worthy of trust people put in them and the party. She said whatever be the results, they should work with the same spirit of devotion to people's welfare. State BJP organisation secretary Bhikhubhai Dalsania said restructuring would be done from January 6 to 13 for mandal-level while the district-level restructuring would be done between January 15 and 21. He said the party had appointed election in-charge leaders for the election of 27 nagarpalikas and observers for organisational restructuring.
