DAYS AFTER COURT SCRAPPED QUOTA FOR GUJJARS

Hardik meets Bainsla, supports reservation demand by Gujjars

DAYS AFTER the Rajasthan High Court struck down Special Backward Classes quota for Gujjars and four other communities, Gujarat's Patidar reservation agitation leader Hardik Patel on Sunday met Gujarat leader Kiron Singh Bainsla in Karauli district and extended his support to the community in their demand for reservation under Special Backward Classes (SBCs).

"They should first ask the government to respond on why they didn't get the SBC Act included in the Ninth Schedule of the Indian Constitution (to make it immune to judicial scrutiny)," Patel told mediapersons in Karauli.

On Friday, the Rajasthan High Court had struck down the notification for five per cent reservation to Gujjars and four other castes under the SBC Act introduced last year by the Rajasthan government, observing that reservation should not be provided "to achieve political goals," and finding several flaws in the process of extending reservation to the five communities under the Act.

"The job of the government has been reduced to just give us assurances, be it state or Centre," Patel said. "We are with Gujjars and are ready to fight along their side. Not just Rajasthan, but the entire nation is with them in their just demand," Patel said.

Patel was on his way to Haridwar when he made a quick stop at Bainsla's residence in Karauli. While Hardik had

'Note ban right move but no surgical strike on black money'

New Delhi: The Patidar quota agitation leader Hardik Patel on Sunday said demonetisation is the right decision to curb black money but cannot be termed as a surgical strike against wealth amassed illegally.

"As far as curbing black money is concerned, it is the right decision but it is not a surgical strike against the wealth amassed illegally. It is a welcome step against corruption. But if it is merely a gimmick then it is not good," he said. "It is okay if the government continues with the note ban but it should also address the problems of farmers and the poor, the Patidar leader said."

Asked if he will join protests against demonetisation, he said, "No, I will not protest demonetisation. I will protest corruption." At a 'Kisan Panchayat' organised by suspended AAP MLA from Bijwasan Col Devendra Sehrawat, Patel claimed that there is no development in Gujarat and the state is reeling under "a debt of Rs 3 lakh crore".

sought reservation for the Patels under OBC category in Gujarat, the Gujjars in Rajasthan already enjoy reservation as OBCs but have been seeking higher reservation through creation of the SBC category.

"It was a courtesy call but we are thankful to him for boosting our morale," Bainsla told The Indian Express.

"Be it Gujarat, Rajasthan or any other state, it is time to fight together. Because the government only gives false assurances and delays it endlessly," said

Gujjar Aarakshan Sangharsh Samiti leader Himmat Singh. "The government is again assuring us that the SBC Act will be included in the Ninth Schedule of Constitution. But for 15 months all they have done was sit on it," he said.

Meanwhile, Rajasthan's Social Justice and Empowerment Minister Anur Chaturvedi said: "We have invited Bainsla for talks on December 15. We want to convey that we are doing whatever we can to give them reservation."

Govt enforces deputation rules on CRCs, BRCs Three drown in Junagadh village pond

INITIATING PERFORMANCE based appointments and reappointment, the Gujarat government has decided to implement deputation rules on government primary school teachers posted as block resource co-ordinators (BRCs) and cluster resource co-ordinators (CRCs).

Through the co-ordinators submitted a representation to the government authorities Sunday, warning mass resignation against these new guidelines, the state government appeared adamant to implement the deputation rules without any delay, impacting nearly 3,500 co-ordinators at block and cluster levels out of the total 4,050 posts. The state government decided to reappoint one-third co-ordinators (1,350) to their parent ap-

pointments (primary schools) every year, following their performance-based review. This number is expected to increase the next year with the department filling the 550 vacant seats soon, as per the guidelines.

"Deputation rules were not applied on CRCs and BRCs whose parent appointment otherwise is as government primary teach-

ers. They were on deputation, some as long as 10-15 years. Since long, the state government has been mulling to implement deputation rules on them. Now, this has been worked out based on their performance, deputation period and maintenance of an online field diary," said Sarva Shiksha Abhiyan (SSA) state project director Mahesh Singh.

As per the revised guidelines issued under the SSA on December 5, 2016, points starting from 1 to 15 are inversely proportionate to the service (deputation) period. For instance, a CRC or a BRC on deputation for the last one year will be given 15 points, and the one on deputation for the last 15 years will be given 1 point.

This is a major bone of contention among the protesting co-ordinators, who gathered in Gandhinagar on Sunday to mark their protest. "Nowhere such a

seniority rule is applicable. We are not against performance-based review and appeal to throw out those who are not performing, but not in this manner," said Gujarat Primary Teachers' Association president Digvijaysinh Jadeja.

The second criterion is based on the average of the Gnutas scores of schools for the last three years (IV, V and VI). While the third is maintenance of online field diary (to be calculated from December 1, 2015 till November 30, 2016) of schools visited by each co-ordinator.

"When the state government has failed to provide internet facilities in each school, how can it expect us to maintain an online diary," contended Jadeja.

The state government has remained firm and directed the co-ordinators to submit review letters till December 12 to the education department.

A WOMAN and her two minor daughters were killed after they reportedly slipped into deep waters while swimming in a pond at Rajoli village of Junagadh district on Sunday.

The incident took place in the afternoon. Police said that Amarben Dangar (45), an agricultural labourer, went to Jun Talav, a pond near the agricultural field where she was working, for washing clothes with her four daughters and a son. While she was washing clothes, her elder daughter slipped into the pond and started to swim. But she slipped into deep waters and started drowning. To save her, the mother also jumped into the water. But she too went under water. A desperate man, the agricultural labourer's second daughter also jumped to save her drowning mother and sister. However, she also couldn't swim and drowned, police said.

Police further said that water was about 15-foot deep and the mother and the daughters got stuck in the slushy bed of the pond.

Live wire to keep off animals kills two men in Devbhoomi Dwarka

A FARMER AND a watchman were electrocuted after coming into contact with a live electric wire another farmer had set around his farm to ward off wild animals in Khambhaliya taluka of Devbhoomi Dwarka district, police said on Sunday.

The incident took place in Bai, a rural village some 27-km away from Khambhaliya town, police said. Rajpal Sindhiya, a farmer of the village had erected a live electric wire around his eight bigha farm to keep wild animals like blue bulls and wild boars etc off. Police said that Rajpal had sown cotton, wheat, millet and fodder crops on his land and set up the wire to prevent the wild animals from damaging the crops.

But in the week hours of Saturday, Rajpal's younger brother Gagu (53) accidentally came in touch with the live wire while working on his farm. After hearing his cries, Mangla Sindhiya (45), who was keeping guard at another neighbouring farm rushed to his help. Police said that Mangla tried to pull Gagu away

from the electric wire but was himself electrocuted to death. "A small dyke separates Gagu's farm from his brother Rajpal's land. At around 5:45 am on Saturday, Gagu came in contact with a live electric wire and was electrocuted. He was found by his brother Mangla. He was taken to the nearest hospital but he died due to the electric shock," police said.

The spot, Khambhaliya police sub-inspector Prabhat Ramani told The Indian Express on Sunday. Ramani, who is investigating officer of the case said that Bai is a resident of a coastal village of Khambhaliya taluka of Devbhoomi Dwarka. The farm of Sindhiya is surrounded by bushes and thickets and farmers said that blue bulls and wild boars raid their fields at night and damage standing crops. In order to protect their

crops from such wild animals, farmer resort to erecting live wires round their farms," Ramani further said. Based on a complaint filed by Mangla's father Vajrangsinh, police have booked Rajpal for culpable homicide not amounting to murder.
